1. ALL IBCs MUST BE EMPTY.

- 2. Fibre Drum Sales, Inc. (FDS henceforth) does NOT ACCEPT ANY HAZARDOUS last contains unless they are 100% legally empty upon delivery.
- 3. IBCs with excessive HAZARDOUS products will be Rejected by FDS and any of FDS's 3rd Party Partners.
 - *Pro-rated inbound freight costs for Non-RCRA empty hazmat inbounds will be charged at a rate determined at the time of delivery to FDS.
- 4. Generator approval for compliant disposal of non-hazardous excessive residue in excess of 1 gallon will be charged at \$25.00 / gallon. If generator chooses to pick up non-hazardous excessive product in order to avoid disposal charges, they must pick up the heavy, non-compliant IBCS freight collect from FDS by the end of next business day. (IN & OUT Fee Charged at \$15.00 / IBC) *Pro-rated inbound freight costs for non-hazardous heavy inbounds will be charged at a rate determined at the time of delivery to FDS.
- 5. Any non-compliant return is subject to a triage processing fee of \$50.00. This fee covers all photos and all follow up communication with the Generator until final resolution of the non-compliance. (IN & OUT Fee Charged at \$15.00 / IBC)
- 6. All IBCs must be DOUBLE STACKED for shipping. All original product labels must be in place. ALL IBCs must have valves operational and closed with safety caps in place and top fill-port screw caps installed.
- 7. Placards must be provided to the Carrier when offering empties with DOT HAZARDOUS last contains (DOT REG. 49 CFR 172.506).
- 8. Metal cage must be reusable. No damage or severe rust to cages or pallets. Non-compliant scrap IBC returns will be charged \$45.00 Each for compliant destruction.

 *Pro-rated inbound freight costs for scrap will be charged at a rate determined at the time of delivery to FDS.
- 9. Wood Pallet IBCs, Wire Caged IBCs & Foreign Cutter IBCs are ALL considered Scrap.
- 10. A BOL will be emailed or faxed back. Please give the original signed copy to the FDS assigned Carrier & make a copy for your records.

 *If the FDS BOL is not received prior to the assigned carrier arrival, please contact FDS immediately. Do Not Proceed with Shipment unless you have the BOL provided to you from FDS.
- 11. Unless Generator arranges the return shipment to FDS, All IBC returns must be transported on FDS's assigned carriers along with the original FDS BOL. Failure to comply may result in the Generator being responsible for the entire inbound freight cost.
- 12. Alterations to the original BOL must be communicated to FDS before the pick-up occurs. Failure to alert FDS and have a corrected BOL issued, the Generator may be held responsible for the entire inbound freight cost.

- 14. By Authorizing this Form, the Generator accepts the terms & conditions of this Agreement and agrees to pay the costs of any non-compliance.
- 15. ALL IBCs MUST BE FREE OF SNOW, ICE & ANY OTHER EXTERIOR CONTAMINATION PRIOR TO OFFERING. Failure to comply will result in a fine up to \$600.00

NOTE: Completion & Return of this form to FDS assures that your company is accepting all Terms & Conditions as stated above.
