Huge Q2 upside. 2022 outlook more positive even as supply chain issues weighs. Raising P/T to \$33.

COMPANY UPDATE

Target: \$33.00 (from \$19) Huge Q2 upside: Revenue was \$220 million (+96% y-o-y), compared with our estimate of \$114 million and consensus \$122 million. Pro forma EPS was \$2.10, compared with our and consensus estimates of \$(0.43). There was no Q2 guidance.

Strong toy industry demand: JAKKS benefited from strong consumer demand that started with SIP pandemic rules that has continued even as the pandemic is about over. The company had broad growth across a wide range of brands and categories, in the U.S. and international. The company had very strong sales of movie toys Sonic the Hedgehog 2 and Disney's Encanto toys in Q2.

Strong Disguise Q2: JAKKS's costume business (Disguise) revenue was \$71 million (+132% y-o-y), the highest Q2 revenue since Disguise joined JAKKS in 2008.

But supply chain issues continue to weigh: The company had weaker margins in Q2 as supply issues added significant costs. The company had elevated freight costs and extended timelines to deliver inventory into U.S. and European warehouses. The company expects this to continue through 2022.

Profitability improved: Cost controls, inventory management, and very large operating leverage were able to offset the higher supply chain costs to gross margins (27.6% vs 28.4% y-o-y). This resulted in significantly higher operating income (\$24 million versus \$2 million y-o-y).

Building inventory: Q2 inventory was +104% versus last year (at \$124 million) vs. a sales increase of 96%. We believe the large inventory levels increases are reasonable to manage the current supply chain issues (delays and higher freight costs) and higher revenue levels.

No guidance: The company declined to provide 2022 guidance.

Raising estimates significantly: We are raising our 2022 estimates for revenue to \$738 million, from \$665 million, and for EPS to \$4.22 from \$3.50.

Toy industry growth helping JAKKS: NPD reported that U.S. sales of toys rose +13% in 2021 (+16% in 2020). The toy industry benefited from SIP and kids staying home which has continued even as the pandemic is about over. We expect 5% toy industry growth in 2022.

Strong 2022 execution so far: Q2 revenue were very strong (reversing declining revenues over the past several years) and helps alleviate investors' concerns that the negative momentum (from the prior three year's bad misses and significantly lowered guidance) is over. 2020 revenue were -14%, but rebounded to +20% in 2021, and is +74% YTD.

Should drive 2022: We believe the strong Q2 and Q1 results and higher inventory levels should drive momentum through 2022. We also note that the company has significantly reduced its costs structure, so profitability has improved and has significant operating leverage as revenue growth returns.

Risk/reward attractive: Maintaining our BUY rating, but raising our 12-month price target to \$33 from \$19, which reflects a P/E multiple of ~7.5x our 2023 EPS estimate of \$4.40. This is below the peer group median for toy companies to reflect higher execution risks but also represents significant upside from the current share price.

OVERVIEW

- JAKKS recently (on July 27) reported its fiscal Q2 2022 (ending June) results.
- Revenue was \$220 million (+96% y-o-y), compared with our estimate of \$114 million and consensus \$122 million.
- Pro forma EPS was \$2.10, compared with our and consensus estimates of \$(0.43).
- There was no Q2 guidance.
- The company did not provide 2022 guidance.
- We are raising our 2022 estimates for revenue to \$738 million, from \$665 million, and for EPS to \$4.22 from \$3.50.
- We are raising our 2023 estimates for revenue to \$746 million, from \$680 million, and for EPS to \$4.40 from \$3.80.

ADDITIONAL DETAILS

- Gross profit for the quarter was \$61 million, compared with our estimate of \$31 million.
- Gross margin for the quarter was 28%, versus 28% last year and our expectation of 27%.
- Operating expenses were \$37 million, versus our expectation of \$33 million.
- Operating income was \$24 million, versus our expectation of a loss of \$2 million.
- Pro forma net income was \$21 million, versus our expectation of a loss of \$4 million.
- EBITDA was \$27 million, compared to our estimate of \$1 million and \$5 million last year.

The company's balance sheet remains relatively seasonally steady with \$62 million in cash and \$85 million in debt, compared with \$39 million in cash and \$95 million in debt as of March. JAKKS has ~\$6/share in cash (~\$2/share in net debt).

The company's Q2 inventory was +104% versus last year (at \$124 million, from \$85 million in Q1 and \$61 million in Q2 2021) vs. a sales increase of 96%. We believe the large inventory levels increases are reasonable to manage the current supply chain issues (delays and higher freight costs).


